

## Dub The Digs Lawrence Naming Contest Terms and Conditions

**No purchase is necessary to enter or win the Dub The Digs Contest (the "Contest").**

**Entry:** To enter, follow directions as outlined at [DubTheDigs.com](http://DubTheDigs.com) ("Entry" or "Entries"). Any Entries must be received by date and time outlined on the website and must not infringe upon the copyrights, trademarks, rights of privacy, publicity or other intellectual property or other rights of any person and must not violate any law. Sponsor reserves the right to disqualify any Entrant (defined below) or Entry in its sole and absolute discretion. Odds of winning depend upon number of Entries received. Entry into the Contest constitutes your acceptance of these Terms and Conditions.

**Contest Period:** The Contest commences at 8:00 a.m. eastern time on Monday, March 26, 2018 and ends at 11:59 p.m. eastern time on Monday, April 16, 2018 (the "Termination Date").

**Eligibility:** Anyone who fulfills the requirements set forth herein is eligible to enter (an "Entrant"). A qualified Entrant must be (a) eighteen (18) years of age or older as of March 26, 2018, (b) a legal resident of United States of America, and (c) enrolled as a full-time student (defined as 12 or more credit hours per semester) at the University of Kansas for the 2017-2018 academic year. Collegiate Communities LLC and its parent companies, affiliates, subsidiaries, advertising and promotional agencies, and each of their respective officers, directors, employees, and agents (collectively, the "Sponsor") and members of the Sponsor's immediate families and those living within the same household as any Sponsor are ineligible to participate.

**Disqualification:** Sponsor has the right to disqualify any Entrant for a failure to fulfill the eligibility requirements discussed above or as otherwise provided herein. Examples of justification for disqualification include failure to comply with these Terms and Conditions, failure to promptly execute and return any required documents, making false or misleading statements, failure to provide current contact information and any updated contact information, or the violation of local or state law.

**Winner Notification:** Winner(s) will be determined within sixty (60) days after the Termination Date and will be notified via the email address provided with the winning Entry.

**Prize:** The winning Entrant will receive a check in an amount of approximately \$2,500 (the "Prize"), which will be awarded within sixty (60) days after the Termination Date. The Prize must be accepted as awarded and no substitutions of any kind will be made. In the event a winner is not selected or a Name (defined below) is not used, Sponsor shall distribute the Prize in full among the top Entrants determined at Sponsor's sole and absolute discretion. To illustrate, if there is no winner yet Sponsor deems there to be five (5) top Entrants, each such Entrant would receive an amount of \$500.

**Judging:** All Contest entries will be judged by a committee chosen by Sponsor (the "Selection Committee") who will be responsible for selecting a winner at the Selection Committee's sole and absolute discretion. **Assignment of Naming Rights:** By entering the Contest, you irrevocably assign and transfer to Sponsor all right, title and interest in the name provided in the Entry (the "Name"), including, without limitation, all trademark rights, and you agree to execute any additional documents Sponsor may deem necessary to evidence or effectuate such assignment.
